## **Rights and obligations of the applicant**

1. Breach of safety and organizational rules as well as disobeying the organizational instructions of the personnel can lead to an immediate revocation of the accreditation.
2. Each applicant must strictly observe all the safety rules of motor sport, follow the instructions of the organizers and line managers. The applicant must behave in a manner that does not endanger the course of the event, their safety or safety of other participants.
3. All applicants must be properly dressed (sturdy shoes, long trousers) to eliminate accidents that could endanger the safety of all participants or damage the property.
4. Each applicant is aware of the fact that motor racing is a dangerous sport and that they attend the event at their own risk. The applicant undertakes that, now or in the future, they will not seek compensation from, put responsibility on, blame or sue either Prosport-CZ z.s. or any participating team or riders and other organizations participating in the business, including the headquarters, individual members, officers, employees, agents, service staff, representatives and contractors in case of personal injury, death or of any kind of loss on the side of the licence holder in connection with their presence at the event.
5. The applicant undertakes not to harm the organizer and not to claim compensation for any damage caused by a third party (personal injury, death, damage or loss of other kind) as a result of or in connection with the organizer's negligence.
6. The applicant for accreditation is obliged to observe the hygienic and cultural rules associated with their work and the workplace it will be performed on. They undertake not to hinder in any way the work of their co-workers and other journalists.

The accredited journalist will receive a vest and a "Press" label against the deposit of 300 CZK. They are required to wear this equipment at least when moving on the track.

By signing this application form, the applicant for accreditation confirms the approval with the attachment of the application "Guide for organizers and photographers on Těrlíčko Circuit".
